RICHARD LOBEL

Richard Lobel is the Managing Partner of Sheldon Lobel, P.C., a zoning and land use law firm based in New York City. Mr. Lobel represents clients in matters before the New York City Board of Standards and Appeals, the City Planning Commission, the Department of Buildings and other regulatory agencies. Richard's practice includes securing zoning and other regulatory relief through variances, rezonings, special permits, vested rights cases and judicial determinations. Richard also represents clients in criminal and civil court on real estate related matters.

Richard serves on the Board of Directors for CAMBA Housing Ventures, a subsidiary of CAMBA. CAMBA is a not-for-profit agency that provides services that connect people with opportunities to enhance their quality of life. CAMBA offers integrated services and programs in: Economic Development, Education & Youth Development, Family Support Services, HIV/AIDS Services, Housing Services & Development, and Legal Services. CAMBA Housing Ventures, Inc. hired Richard to obtain a variance for a Brooklyn property at the Board of Standards and Appeals, which was granted in 2009. Since then, Richard has offered continuing legal services to CAMBA with regard to numerous supportive housing projects.

Richard also represents Lantern Organization, a not-for-profit sponsor and provider of affordable housing, including for people living with continuing disabilities. Richard has represented Lantern in numerous variance applications which have received grants from the BSA, and has successfully defended variance grants on behalf of Lantern in New York State Supreme Court.

Richard also serves on the Board of the June Stern Family Foundation, a nonprofit organization dedicated to helping K-3 general and special-education teachers and reading specialists to more effectively teach reading, writing and spelling, with a focus on dyslexia awareness and education. Through his legal work, Richard and his firm have helped over 100 schools to open throughout NYC, including the Children's Learning Center, a pre-school program in Upper Manhattan for children with disorders on the autism spectrum. Having had countless conversations with teachers and administrators, Richard is no stranger to the importance of helping others around the goal of benefitting children, and is extremely proud to have been asked to be this year's T Off 4 Autism Honoree.

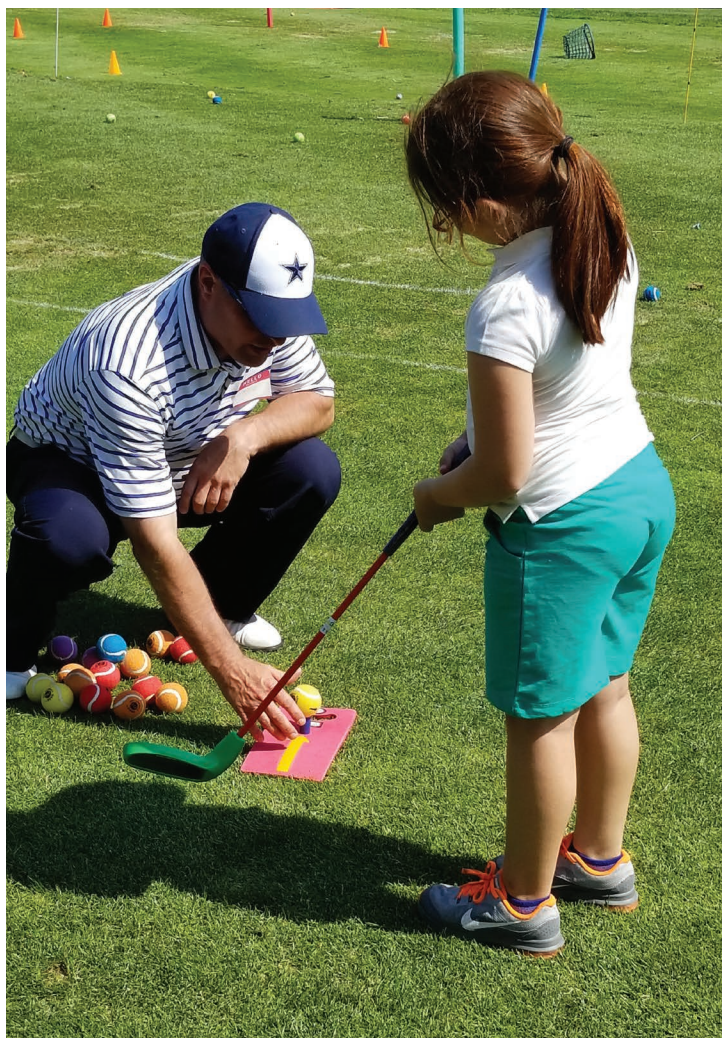
